

### **ACTRES PILOT COMPLETED**

In the first two weeks of February 2004, nine growers started a pilot using ACTRES. The aim of this pilot was to gain insight into how ACTRES works and to give growers the opportunity to give practical input on its relevance and 'user friendliness'. On the basis of their reactions, bottlenecks and improvements have been listed. Some of these have already been solved and the rest of the bottlenecks will be solved as soon as possible. ACTRES is currently being translated in English. The translation will be completed by the end of June.



The pilot-participants are positive about ACTRES. Some of the participants say that from now on they only want to submit via ACTRES. One of them is Nick Groenewegen from Kalanchoë nursery "De Veranda" from Honselersdijk, the Netherlands. Nick is, as he says himself, very positive about ACTRES. "Now I don't have to fuss with a mass of paperwork anymore. I can submit my data anytime and online. I find working with the gas meters very handy; you only have to fill in the meter reading and everything is easily calculated. I don't have to write everything down and add it up with a calculator. The programme saves me a lot of work. ACTRES has many benefits. It is very easy to check your stock. In the system you can see what is still in the cupboard. In this way, it is also a back-up for stocktaking. The overviews are easy to read and useful. You can also register per division, I don't do this myself, but for others this will be useful. Furthermore, you can register per worker what has been sprayed and why. It is simply a quite beautiful registration system with which you can register per day, per week or per month!" according to Nick Groenewegen.

The three companies are the first Flemish companies that have obtained the MPS-GAP-certificate in Belgium. The certificates were officially presented to each company in a fine frame, courtesy of VMS. The MPS-GAP companies were congratulated by hearty applause.

### Kenya: Successful meeting with Kenyan MPS-growers

### STANDARDS & ENVIRONMENTAL CLUSTER

### Standards ALSTROEMERIA (Kenya/Tanzania)

MPS evaluated the standards for ALSTROEMERIA (mc-code 2001) also known as Peruvian Lily. The conclusion, as a result of the evaluation, was that the fertiliser limits should be raised. The new standards (see table 1) will apply from period 1 2004'.

Table 1: Current and new standards Peruvian Lily (Kenya/Tanzania)

### MPS-GAP, the quality label for the supermarket

MPS-GAP fits perfectly into the present developments around MPS and the market; particularly the developments round the supermarket chains. While our previous slogan was: "Making the difference for man and nature", MPS' new slogan is quite appropriately: "One window for registration and certification". Why you may possibly wonder? The large supermarket chains especially in England, France, Switzerland, Scandinavia and to a lesser extent in Germany are putting more and more pressure on the chain. The impact of this could be enormous for both the floriculture sector and the bulb sector. Chains like Tesco, B&Q, M&S, Carrefour and Auchan but also the Swiss MIGROS and Coop require trade and growers to meet certain demands regarding source of supply, quality, use of agents, sustainability and corporate social responsibility.

Recently Mr. Zublin and Mr. Schumacher, responsible for the quality of flowers, plants, vegetables and fruit at MIGROS, visited MPS. They met with Theo de Groot (Managing Director MPS) and spoke about international developments. MIGROS expressed their admiration for the professionalism of the MPS-organization. Particularly the theme "One window for registration and certification" appealed to the visitors. "MPS has everything to show growers the way", was their opinion. During the visit they also visited two MPS-GAP certified growers, namely Sjaak vd Voort B.V. and nursery A. Stolk. The obvious motivation of the growers to do MPS-GAP was noted. The gentlemen from MIGROS worried about the fact that too many growers wait too long to obtain GAP-certification. A number of well-established supermarkets will follow the GAP-line. In particular, a number of wholesalers are lagging behind the development of increasing trade in GAP-products. MIGROS' policy is aimed at having all suppliers (read: producers) of flowers, plants and bulbs satisfy the GAP-requirements this year still. MIGROS will keep a close watch on the GAP certificates used – these will have to be 'genuine'. This means that the schemes as well as the auditors have to be accredited. There are many schemes in the market that will not pass this critical test. Furthermore, it is important that not only the registration of the agents is reliable, but that the quantity and content are also actively checked. Otherwise unfair competition regarding the use of crop protection agents may arise.

MIGROS' policy is aimed at remaining at the forefront of the market for certified products, in the field of environmental and social aspects. And, in that field, MPS is an organisation with the same aim. Both the (exporting) trade and the growers will have to comply with the wishes of buyers if they want to maintain or strengthen their position. To that end, MPS has developed the MPS-GAP certificate which compares effortlessly with EUREPGAP.

### What does the MPS-GAP certificate entail?

- MPS-GAP is benchmarked against EUREPGAP flowers and plants. Now MPS-GAP is equivalent to EUREPGAP (if you are MPS-GAP certified, you are also EUREPGAP certified).
- International Standard
- Meets the requirements of the supermarket chains
- Environmental registration is anchored in standards
- Enhanced image for your company and the sector
- Ease and gain





Do you want to keep ahead of market developments, consider the following quote, spoken by an M&S executive: "This is one of the newest and highest GAP standards within the flower industry worldwide. This is a significant milestone in our policy to have all growers GAP audited by the end of 2004." Our comment is: "It's a great opportunity for the floriculture sector".
